Finance Board Update:

Anderson stated that the finance board has met twice since the last board meeting. They reviewed and approved all department invoices of \$15,439.14 and the expenses were underrunning. Cumings stated that the department received \$5300 in delinquent millage and \$4200 accumulated monthly interest. With a fund balance of \$1,185,673.

Old Business:

The USDA grant update: The chief received confirmation that we finally have approval as of July 3, 2025. There is a letter of conditions, ABAAS agreements, Attorney's approval of Architectural Service and Certification for Accounting Systems that need to be filled out, signed and returned. The Chief with contact Andrus Architectural for ABAAS agreement and a new Service Contract for the station work.

The next step is starting the process of getting bids for the project. The Chief stated he's like to break the project into (3) bids. 1. New office and existing station remodel. 2. New station addition for apparatus. 3. Combined bids for option 1 & 2. The Chief stated that its costs are within the scope of our finances; he'd like to do option #3. However, if the bids for option #1 are the only option that can be completed within the range of our finances, we would just do a portion of the project. It was the consensus of the board to arrange bid and alternative bids. The Chief will get the building committee and Andrus Architecture for a meeting to start the process.

Station Funding Update: The Chief stated that at the last township meeting the township board did not sign the updated financial joint agreement. The township tabled the request for the possible need for additional funds for the fire department building addition. The Chief stated that a decision will not be needed until sometime after the bids for the building are known.

Fire Authority: The Chief stated we received from our attorney Act 57 Fire Authority for the process of getting started to the boards request to become a "Fire Authority". The Chief stated he's sent a list of equipment, other assets, building ownership and vehicle ownership to our Attorney. The Chief stated that everything was in the name of the Sparta Fire Department. He'd also sent the current fire agreement between the village and township so he can get started with the Fire Authority Agreement.

Chief's Report: Chief Olney presented the Chief's report. (attached) There were 586 runs YTD. There were 2 mutual aid calls and 1 structure fire last month. There were 6 accidents, with 3 minor injuries this past month. Several alarms and hazardous conditions due to the latest storm which swept through the township. The Chief stated that he'd received additional requests for information on the FEMA for Air PAC's for Sparta and 4 other departments. He said it still means were still in the running for the grant.





Count of Incidents






Incident Count by Shift

SUMMARY OF REQUEST:

The Village of Sparta has received a formal request from the Peterson Family to annex their property located at 11250 Sparta Avenue into the Village. Although the property appears as two separate parcels on mapping systems due to the railroad right-of-way, it is legally recognized today as a single parcel.

Parcel Characteristics & Access:

- East of the railroad tracks: This portion has potential access from Aspen Street.
- West of the railroad tracks: This portion fronts Sparta Avenue and also has the potential to connect to Union Street via adjacent Village-owned property.

Proposed Use:

The Peterson Family intends to develop the property and desires access to Village municipal services (water, wastewater, stormwater, etc.).

- The eastern portion, being near a village park and established residential area, is most suited for residential housing.
- The western portion could support commercial, business, or mixed-use development, potentially blending business and housing.

Planning Context:

- The property is identified in the Village Master Plan as a potential future growth area.
- Sparta Township was informed of this designation during the master planning process.
- Upon receipt of the annexation request, Village administration immediately notified Sparta Township and Kent County of the pending request and possible action by the Village Council.
- If annexed into the Village, staff will coordinate with the Peterson Family through the site plan review process to ensure appropriate development, infrastructure connections, and alignment with zoning and land use goals.

FINANCIAL IMPACT:

- **Short-term:** Approval of annexation by Kent County will result in only a minimal immediate gain in taxable value for the Village.
- **Long-term:** Once the parcel is developed, the Village will benefit from new water and sewer customers as well as increased property tax revenue, providing a meaningful and sustainable boost to Village finances.

SUMMARY OF REQUEST:

Per Section 74-272 of the Village of Sparta Sewer Use Ordinance, the Village Council has the authority to appoint a Wastewater Board of Appeals from time to time, as needed. Given recent incidents involving large users of our system, it is in the Village's best interest to formally establish this board at this time.

The purpose of the Wastewater Board of Appeals is to hear appeals from users regarding decisions made by Village staff in the enforcement and implementation of the ordinance.

The ordinance requires that:

- At least one licensed engineer be appointed, and
- All members possess background knowledge and experience with wastewater systems sufficient to make informed decisions.
- No members may be employed by the village department of public works.

To meet these requirements, the following individuals are recommended for appointment:

- Robert Carlstrom Village Council member, Utilities Committee member, licensed wastewater professional, and employee of the City of Grand Rapids Wastewater Treatment Department.
- **Robert Whalen** Village Council member and Utilities Committee member with direct oversight experience of our wastewater operations.
- Courtney Mais Village Council member and Utilities Committee member with knowledge of the Village wastewater system.
- **Bruce Pindzia** Semi-retired professional engineer with extensive wastewater and municipal utility experience.
- **Anthony Moterusso** Licensed wastewater system operator for a neighboring municipality, Sparta area resident.

Collectively, this group meets the requirements of the ordinance and brings the technical expertise and governance background necessary to serve as a fair and qualified appellate body for wastewater-related decisions.

REQUEST SUMMARY:

Following a public hearing and deliberation, the Planning Commission voted 6–1 to recommend approval of Ordinance 25-02 to the Village Council.

Key Discussion Points

The primary concern raised at the hearing involved the conceptual drawing of apartments shown within the proposed RH district. Staff has reviewed the area and notes the following:

- Much of the land identified for RH zoning consists of wetlands.
- These areas were intentionally left undeveloped in the original PUD for that reason.
- Any development within wetlands would require formal approval from EGLE. Given costs and permitting hurdles, it is highly unlikely that development of this area would be feasible.
- The Village also retains the ability to deny development in this area through the site plan review process if appropriate.

It is important to emphasize that Ordinance 25-02 addresses only the zoning designation of this property. Site plan approvals are a separate process administered by the Planning Commission and staff.

The Village appreciates the input received from residents during the public hearing. While this ordinance pertains solely to zoning, the concerns expressed will be taken into account during the site plan review process if the council approves Ord. 25-02.

SUMMARY OF REQUEST:

The Bedford Falls Planned Unit Development (PUD) has a long history with multiple changes and delays over the years. As it stands today, the western and southern portions of the property remain prime developable land within the Village of Sparta. However, the original PUD agreement for these sections has expired, market conditions have shifted significantly over the last two decades, and the Village has updated zoning ordinances to allow for greater flexibility and density in housing development.

The current rezoning request is the first step toward reactivating this property for new residential development, including single-family homes, condos, and apartments. Four entities are involved: Peterson Financial (current property owner), Allen Edwin Homes (proposed purchaser of the single-family portion), CD Barnes (quad-plex builder), and the Village of Sparta. Peterson Financial intends to sell the single-family section to Allen Edwin Homes, develop the quad-plex units with CD Barnes, and secure entitlements for the proposed apartment complex before selling that portion to a future builder.

For this meeting, only the rezoning requests are under consideration. Staff and our engineering/planning consultant have reviewed the proposals and find them appropriate. The RH rezoning area will align with other RH properties to the west and north, while the RM areas will transition appropriately to existing RM zoning and single-family development within the original Bedford Falls PUD. The proposed mix of uses is consistent with the original vision for the PUD.

Future meetings will address the preliminary plat for Allen Edwin Homes and a detailed site plan for the condos/apartments. The RH portion shown today should be viewed as conceptual at this stage, while the RM plan is more developed but still under revision prior to formal review by the Planning Commission.



SUMMARY OF REQUEST:

The Village Council formally appointed the Citizens Advisory Committee on Cityhood via Resolution 25-06 in March 2025. The committee met formally six times and concluded its work by the August 13, 2025 deadline outlined in the resolution. In addition, the Chairman and Village staff met informally with Township officials as part of this process.

The committee voted 5-0 to recommend that the Village move forward with incorporation as the City of Sparta. The background and rationale for this recommendation is contained within the attached report.

At the council meeting, Chairman Carlstrom will present highlights of the report. Following this, the Village Council will have the option to formally accept the report and discuss potential next steps

Executive Summary

The Village of Sparta Citizens Advisory Committee on Cityhood recommends that the village begin the process of becoming a city. This change represents a natural and necessary step forward in modernizing local governance, improving service efficiency, and delivering long-term tax savings for residents. Villages in Michigan were historically designed as transitional governments. Sparta's continued use of the 1895 General Law Village Act as its governing document is no longer reflective of the needs or size of our community. Transitioning to a city structure allows residents to shape a modern charter tailored to Sparta while eliminating overlapping jurisdictions, improving service coordination, and enhancing voter representation.

This report outlines the rationale, implications, and mechanics of the change. Based on our analysis, the change to cityhood can be achieved with:

- A net tax savings of 1.2 mills for residents.
- No disruption to fire protection services.
- Clear voter choice on library service models.
- Modernized governance and full local control.

This is not an expansion of boundaries or a work around for annexation. The change is entirely structural and administrative in nature. Our small-town character will remain unchanged; however, our government will better reflect our independence, efficiency, and future.

Introduction: Why Cityhood?

Sparta is one of the largest general law villages in Michigan. As a general law village, it operates under the state General Law Village Act of 1895. This act was not designed for permanent, modern governance of a municipality of Sparta's size and complexity.

Villages share jurisdiction with their underlying township. In Sparta's case, that means residents pay taxes to and receive services from both the Village of Sparta and Sparta Township. This dual layer of government results in inefficiencies, overlapping services, and diluted representation.

Key reasons to incorporate as a city:

- Greater local control over services and elections
- Modern, voter-approved charter designed by residents
- Financial savings from removing township millages
- Clearer identity and representation in regional governance

Cityhood is the natural next step for a thriving, independent, and efficient municipality.

Legal and Structural Overview

Becoming a city will:

- Establish a City Council to replace the Village Council.
- Require the formation of a Charter Commission, selected by voters, to draft a new city charter.
- Remove Sparta properties from Sparta Township's jurisdiction, including its millages and governance.
- Leave the village boundaries unchanged (this is not annexation).
- Allow the city to retain all taxing authority currently held by the village, without requiring new taxes.

The Cityhood Committee recommends that the new charter:

- Maintain the current voter approved cap on property taxes
- Prohibit a city income tax permanently
- Preserve voter control over any future tax changes

Understanding Sparta's Fiscal Share of the Township

To assess the fairness of financial contributions and asset division, the committee used two key indicators:

- **Taxable Value Split:** Based on the total taxable value of all properties, the Village of Sparta accounts for approximately **43%**, while the remainder of Sparta Township makes up **57%**. This proportion reflects how much of the property tax base lies within the village.
- General Fund Contribution Estimate: Because some general fund revenues (like state shared revenue, permits, etc.) are not directly tied to property taxes, a more conservative and representative method was used. By analyzing factors such as taxable value, service utilization, and millage rates, the committee determined that the village represents 15% to 18% of the overall township general fund contributions. This ratio is being used to guide proposals for the division of cash, investments, and real estate assets currently held by the township.

This dual analysis ensures a balanced and evidence-based approach to fiscal negotiations during the cityhood transition.

Administrative Services: Assessing, Elections, and Other Services

Currently, the township provides assessing and election services to the village. As a city, Sparta would assume these functions.

Estimated costs: \$50,000 annually

New revenue: \$58,000 in tax administration fees (currently paid to the township)

This results in a **net gain** and allows Sparta to:

- Manage its own assessment process
- Control election timing and ballot content
- Maintain its own voter registration records
- Ensure all decisions are made by and for city residents

These services will be brought under one roof, eliminating duplication and confusion for residents.

Assessing/Property taxes in particular create a lot of confusion for residents, especially during the summer levy. This is because village residents get a bill from both the township and village on this levy. They often ask the village questions we cannot answer because the assessor works for the township. It makes it look like we are giving residents the run around, when in reality it is a consequence of our inefficient and outdated governmental structure. The change to Cityhood will fix this problem.

Concerns have been expressed by village residents that the current assessing system and board of review has the unintentional consequence of favoring properties outside of the village. Under a cityhood model the board of review members and assessing staff will be directly accountable to city voters. To the extent these concerns are valid, this change would likely help correct the situation in the committee's opinion.

The new village (city) complex that is being built is designed to accommodate elections services in the event the village becomes a city. The new meeting room is an ideal place to hold elections. There is ample parking in the front of the building, with overflow parking available in the back if needed. The new building is also equipped to handle the requirements of early voting as well. Like with the assessing services, the committee believes bringing these services under our administration will improve their delivery and reduce confusion for residents.

The new complex was designed to provide a one stop shop for services currently delivered by the Village of Sparta. This would be further enhanced under a change to cityhood by making the complex a one stop shop for all business related to the resident's local government. All issues and questions related to the city will be handled fully by the city.

Fire Protection Services

Sparta currently partners with Sparta Township for fire protection. This relationship can and should continue under cityhood. The current joint service model is functional and provides coverage to both the village and township residents. A conversation regarding updating the structure of the fire department is ongoing as well. The Joint Fire Board recently recommend that the Township and Village explore forming a joint authority for fire protection services. A new authority, much like a transition to cityhood, would modernize the governance of the fire department and make it more efficient as well.

City financial contribution:

- \$138,333: Contract cost for services
- \$80,723: Replaces falling-off fire millage
- \$46,038: Replaces township general fund support (based on 18% share)
- Total: \$265.094

This amount maintains the village's current financial contribution under cityhood and ensures uninterrupted service. It also appropriately backfills lost revenue currently provided by the millages assessed by the Township and the factored general fund Township contribution that will be lost.

Cityhood will not create gaps in fire protection, nor require the city to start its own department. In the future the fire authority could explore a fully millage-based funding model for the fire department. If approved by voters, the city would then reduce the city millage assessments to offset the fire authority millage. Doing so will ensure that City residents will not be subjected to a tax increase for fire services if a future authority shifts to a millage only funding model.

Library Services Options

The Carnegie Library is currently owned and operated by Sparta Township. It receives the following funding indirectly from the Village of Sparta:

- \$40,690 from village residents through the millage
- \$32,400 from township general fund (18% village factored share of the Township General Fund)
- Total potentially lost after cityhood: \$73,090

Post-cityhood, the city will no longer have an automatic voice or share in funding decisions unless a new agreement is reached. The committee recommends exploring the following to fund library services:

Form a Joint Library Authority with the township:

- o Requires agreement on board structure and governance
- Ensures continued use of the Carnegie Library
- o Gives city formal representation in library governance

If step one is done, then voters could Adopt a Dedicated City Library Millage:

- Maintains current funding levels
- Supports continued access and materials
- Must be approved by city voters

Partner with Kent District Library (KDL):

- Offers system-wide access to all KDL branches and digital resources
- o Sparta's new city complex could serve as a local service hub on a limited basis if needed
- Funded either by contract or new city millage (typically ~1.1 mills)
- Voter approval is also required
- o City would have a seat on the board of KDL as part of any agreement

The Committee recommends that **no city funds be contributed to library services without governance rights**. Residents should be presented with all service and cost options, and vote on the preferred model during or after the transition process.

Financial Implications Summary

Residents would immediately stop paying the following township millages:

• Township General Operating: 0.9546 mills

Fire Millage: 0.4749 mills

Library Millage: 0.2419 mills

Initial savings: 1.6714 mills

After adjustments for fire contributions:

Net savings: 1.2 mills

If voters approve library millage (0.4345 mills):

Net savings: 0.7655 mills

The KDL option at 1.1 mills would still result in a minor tax reduction from current levels (voters would have to approve this or any option).

Transition costs: (~\$50,000) will be covered by Sparta's share (15–18%) of township assets.

A more detailed financial analysis was produced by the committee and made available on the village website as well. Please refer to this document for more information on the financial picture.

It is also worth noting that Sparta Township is facing significant financial challenges at the present time. They have mounting expenses related to their facilities and a large drain assessment. The village residents and also the village as an organization will also be paying assessments as part of this drain project. Because 15-18% of the townships funding comes from the village, residents are essentially paying for a share of that project outside of the village as well. This is just one of many examples of the financial drawbacks of continuing with the village model. The drain situation is not any particular person or entity's fault. Rather, it is a consequence of the structure we currently live under and a relevant/timely example of why the committee believes a change will be beneficial to residents of the new city.

Pros and Cons Summary

The committee produced an expansive and detailed Pro's and Con's list which is available on the village website. Below is a selection of the key items the committee wishes to highlight.

Pros:

- Full control over elections, taxes, assessments, and services
- Elimination of dual government oversight (village and township)
- Tax savings for residents (1.2 mills or more)
- Greater flexibility and efficiency in delivering local services
- Charter can ban city income tax and cap property tax rates
- All elected officials and ballot issues decided solely by city voters
- Stronger voice in intergovernmental partnerships
- Clarifies governmental identity for economic development
- Eliminates cross-subsidization of township-only services
- Ensures all local taxes are used to benefit city residents
- More responsive government focused entirely on City of Sparta residents
- Legal protection from township-related liabilities
- Headlee caps on properties stay in place, no pop-up tax will occur
- Transparent fiscal asset division based on village's real contribution share (15–18%)

Cons:

- Residents can no longer run for township-level offices
- One-time costs for legal work, charter development, and transition (~\$50,000)
- Asset division must be negotiated or mediated (no state formula)
- May need to renegotiate roles in joint authorities

Discussions with Sparta Township

Township board members and/or staff, as well as non-village township residents attended every committee meeting and had the opportunity to speak. Representatives of each organization also met separately and communicated over the phone and email. These conversations were productive and helped set the table for the eventual division of assets and transition conversation that will be required as part of this process.

Final Recommendation

The Cityhood Committee strongly recommends the Village of Sparta begin the legal process to incorporate as a city.

This change provides:

- Long-term financial savings
- Modern, independent governance
- Clear representation for city residents
- No disruption in the delivery of critical public services
- Improved coordination, efficiency, and identity

Our recommendation is not just about governance. It is about empowering our community with the tools it needs to chart its own course, serve its residents better, and do so more affordably. Cityhood is a modern solution for a modern Sparta.

Fuel Sales:

Hangar Construction:

The Johnston hangar construction is on schedule and nearing completion. The building is up and the floor and apron concrete have been poured. Interior work has begun and the hangar door will be assembled and installed next. The footings have been set for the Dykstra hangar and the walls should go up soon. Todd Vriesenga has the permits for his construction and the land lease is complete and will be signed in August for a proposed start date of September 1. I have received interest from two parties on the final remaining hangar spot in that area. I am waiting on plans/proposals and hopefully we will have construction completed for that last hangar spot in 2026. See attached construction area layout.

Airport Inspection

We passed our three-year airport inspection which was completed by MDOT Aero. They were very pleased with all of our tree removal efforts and complimented the condition of the airfield and facilities. The inspectors were also impressed by the amount of activity on the field including all our airfield upgrades, hangar construction, and upcoming projects. The inspection report is attached.

Jet Fuel Farm and Crack Sealing (State/Local Grant Projects)

The contract was signed with MDOT for construction of the Jet Fuel Farm and we received the first payment for half of the grant amount. Construction begins in September in conjunction with the Apron Reconstruction and Taxiway Connector Projects. Dean's Excavating will be doing the excavation and new pavement section and Rohr Gasoline Equipment is installing the tank and associated plumbing, filtration, and self-serve equipment.

The State/Local grant also included dollars for completing the crack sealing that remained after our 2024 State Crack Sealing project. Fricke Asphalt should begin this project in September as well and when completed all airport pavements should be in good shape for another three years until the next round of state dollars is available for crack sealing.

Events

In July we hosted the Michigan Aeronautics Commission (MAC) bimonthly meeting. The feedback we have received from MDOT and MAC has been very positive. They were impressed by the work that has been done and commented that Sparta Airport has been a good steward of the Federal, State, and Local dollars spent here. The attendees were told that Sparta was an excellent example of what a General Aviation airport can be with strong sponsor (Village) support and our willingness to work cooperatively with State and Federal aviation authorities. Thank you to Jim Lower for helping with developing and delivering our airport presentation to the MAC board. The Airport Power Point presentation is attached.

We hosted our second airport user appreciation "Grill & Chill" event and it went really well. We again had a good turnout, especially considering the hot and humid weather. These cook-outs were intended to be a thank you to the people who utilize our airport and an effort to continue building a vibrant airport community which helps drive growth. Again, a big thank you to our EAA Chapter 704 for their help and to Larry Bauer for the use of his hangar!

Water System Operations & Regulatory Compliance

- July 1: Issued internal staff policy formalizing the Village's transition from nutating disc meters to ultrasonic meters, which offer improved accuracy, no moving parts, and longer service life.
- July 14: Sent meter change-out letters to water customers with zero usage, indicating likely inactive or malfunctioning meters.
- July 14: Corrosion Protection Specialist inspected cathodic protection at the East Tank.
- July 15: Distributed new round of lead service line replacement notification letters to affected customers.
- July 16: Ordered a new cover for the Village's brine day tank due to extensive corrosion perforation.
- July 16: Submitted required documentation to EGLE ahead of the scheduled Sanitary Survey.
- July 17: Finalized and submitted the updated Water Reliability Study to EGLE.
- July 17: Made corrections to the Water System SOP to reflect recent operational and procedural changes.
- July 22: Ordered and installed a new mixing valve for the brine bulk storage tank.
- July 29–30: Completed the Sanitary Survey inspection with EGLE for the Village's water system.
- Ongoing: Staff discovered overfeeding of chlorine to the iron removal system via analysis of high
 chlorine levels in backwash discharge. We are now optimizing dosing rates by performing hourly
 testing of iron and chlorine and adjusting feed levels accordingly to maintain a target free chlorine
 residual of 0.8–1.0 mg/L leaving the plant. Post-chlorination settings are also being adjusted in
 coordination.

Tree & Vegetation Management

- July 14–August 13: Conducted tree trimming across multiple locations.
 - Notable activity on August 4 included major tree trimming and removal on 12 Mile Road to improve driver and pedestrian visibility.
- July 28: Issued RFQ for annual tree work within the Village right-of-way.

Street & Infrastructure Maintenance

- July 14—August 5: Daily park maintenance, routine street maintenance, and equipment maintenance were completed (excluding weekends).
 - o Notable local street maintenance and sweeping on July 23–25.
- July 30: Executed an agreement with a property owner regarding the improper installation of an irrigation meter, ensuring future billing accuracy.
- July 30: Hired Superior Asphalt to complete patch work throughout the Village.

Public Facilities

- July 16: Completed Civic Center maintenance and tree survey.
- August 4–5: Brush pickup and Civic Center maintenance completed.

Community Outreach & Public Notices

- August 5: Drafted and published a press release regarding the dog park drinking fountain, informing the public it will be out of service until the end of September due to supply delays.
- August 7: Final notices prepared for properties overdue on Cross Connection Control testing and inspection.

Planning & Asset Management

• August 7: Met with Prein&Newhof to review updates to the Village's Asset Management Plan for water and sewer infrastructure.

Other Activities

- July 15: The Resilient Watershed Group installed a flood gauge at Nash Creek.
- Ongoing: A total of 280 Miss Dig locate requests were cleared by staff during this period.

Summary:

The following report is an overview of operations at the Village of Sparta WWTP

July 2025 Flow Data

Wastewater Treatment Plant flow:

- 15.755 M gallons treated for the month
- 0.602 M gallons max daily flow
- 0.508 M gallons per day average

Algoma Township flow:

- 912,858 gallons treated for the month
- 42,307 gallons max daily flow
- 29,447 gallons per day average

Significant Events/Emergency Callouts:

There were no violations for the month of July.

- We are continuing to write SOPs, perform preventive maintenance, and do housekeeping.
- We are continuing to update our laboratory QA/QC program. This has involved re-writing outdated approved methods and SOP's, running duplicates, spikes, reference samples, and interlab splits.
- We are continuing to update our laboratory chemical inventory and SDS program.
- Staff have been cross-training at the water plant and DPW garage.
- Continued cataloging our assets for an asset management program that will improve maintenance schedules.
- We are continuing to collect composite samples and run lab on Old Orchard.
- Working with Fleis and Vandenbrink on plant upgrades and design.
- Continuing to optimize the iron removal backwash system at the water plant.
- Started our quarterly hexavalent chromium sampling of the collection system that runs from 7/7 to 7/11.
- Trace Labs was on site to collect quarterly hexavalent chromium and low level mercury samples for our NPDES permit on 7/16.
- The main drive for final clarifier #3 started making quite a bit of noise on 7/22. Found the gearbox had accumulated a fair amount of condensation. Drained and replaced oil and the grinding went away. Made a maintenance schedule to regularly drain condensation on clarifier drives.
- Biotech Agronomics is on site to haul sludge from storage tanks 2 and 3 starting 7/24.
- Found our rotary lobe pump that we use to transfer sludge between digesters plugged on 7/25. This apparently has been an ongoing issue for years. The pump outlet reduces from 6" to 4" and it seems likely that is where it is getting plugged. I was able to install a hose fitting on the suction side to feed water to the pump and that has cleared any blockages.
- Old Orchard had low pH readings of 4.1 along with increased flow on 7/24 and 7/25. We could see the effects on the treatment plant and pond in the following weeks.
- Submitted our annual Pollutant Minimization and Source Tracking for Hexavalent Chromium to EGLE on 7/25.
- Submitted our Nondomestic User Survey to EGLE on 7/30.
